    - Notification ratio is below 1:5 possibly/probably due to new ITIC
    - Most employees are working from home; some are in office

- Outreach report by Jill
  - Going strong with outreach plan until pandemic hit
  - NE Excavation safety summit largest volume since inception 10 years ago
  - Pandemic had effect on school poster contest, presentations, stakeholder meetings; still able to carry out most campaigns including media
  - Excavator Manual still working on update, should be printed within the next month
  - 811 Day expanded dig site visits since other industry outreach has been cancelled; tried new virtual campaign on social media
  - Fall stakeholder meetings will be virtual
  - One Call Grant will use all money awarded for 2019 grant and ask for extension on money that can't be used. Just awarded 2020 grant at 78% of request due to dividing a finite total among all those that asked.
